



CHARGES FOR BUILDING REGULATION APPLICATIONS IN FAREHAM AND GOSPORT BOROUGH FROM 1ST OCTOBER 2010

New Dwellings and Conversions to form dwellings

The charges for Building Regulation work are required to cover the cost of providing the service. There are two methods of establishing the charge for new dwellings or conversions:

1. Individually Determined Charges
2. Standard Charges

Individual determination of a charge

Charges are individually determined for the larger and /or more complex schemes including

- Works consisting of the erection or conversion of 20 or more dwellings or
- Works consisting of the erection or conversion of a dwelling where the floor area of the dwelling will exceed 300m²

Standard Charges for dwellings and conversions

These charges have been set on the basis that:

1. The building work does not consist of, or include, innovative or high risk construction techniques.
2. The duration of the building work from commencement to completion does not exceed 12 months.
3. The design and building work is undertaken by a person or company that is competent to carry out the relevant design and building work.
4. There are no major variations to the project design and additional costs are incurred by the Building Control Partnership in respect of additional checking and/or inspection work.

Projects not complying with the above conditions supplementary charges maybe incurred.

Payment Details for projects in either Fareham or Gosport – Cheques should be made payable to 'Fareham Borough Council' Payment may also be made by cash or debit card.

Supplementary Charges for electrical work – Where electrical work is carried out by a person who is NOT a 'competent person' registered with a Government approved self certification scheme an additional charge will be made as follows:

- Certificated notifiable electrical work £120 (£141 inc VAT)
- Non certificated notifiable electrical work £240 (£282 inc VAT)
